ADOPTION OF CHILDREN ORDINANCE (CHAPTER 61)

REGULATIONS made by the Minister of Public Administration and Home Affairs under section 16B of the Adoption of Children Ordinance.

Regulations

- 1. These regulations may be cited as the Adoption of Children Regulations.
- 2. Every written application made to the Registrar-General under section 10 (5) (a) of the Adoption of Children Ordinance (hereinafter referred to as the "Ordinance") for an order directing the alteration of the particulars in the Adoption Register relating to the name of the adopted child, the name or names of the adopters shall be in the form A set out in the Schedule hereto.
- 3. Every written declaration made to the Registrar-General under section 10 (5) (d) of the Ordinance for the Correction of any error in any Particulars in an entry in the Adoption Register relating to any matter of fact or substance shall be made in the form B set out in the Schedule hereto.
- 4. Every written declaration made to the Registrar-General under section 10B (1) of the Ordinance for the re-registration of the birth of an adopted child shall be in the form C set out in the Schedule hereto.
- 5. Where the Registrar-General is satisfied that the spouses making the declaration in the form C of the Schedule hereto have been authorized by a Court to adopt the child in respect of whom form C of the Schedule hereto have been authorized by a Court to adopt the child in respect of whom such declaration has been made, he shall direct the Registrar of the division in which the birth of that such accuration has been made, he shall direct the Registrar of the division in which the birth of that child in the register provided for the registration of births under the Births and Deaths Registration Act by inserting the relevant particulars of the matters set out in the form C of the Schedule hereto and all the provisions of the Births and Deaths Registration Act relating to the registration of the birth of a child shall mutatis mutantis apply to the registration of a birth of an adopted child under this Ordinance registration of a birth of an adopted child under this Ordinance.
- 6. Where the birth of an adopted child has been re-registered under the provisions of this Ordinance the Registrar-General shall cause the relevant entry in the Adoption Register in respect of that child to be marked in red ink in the margin of that register with the following particulars in addition to the words "Births Re-registered":——
 - (a) The Division in which the birth has been re-registered.
 - (b) The date and number of the birth re-registration entry.

Such particulars shall be authenticated by the Registrar-General or an officer authorized by him in that behalf.
